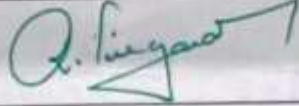
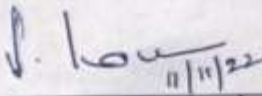
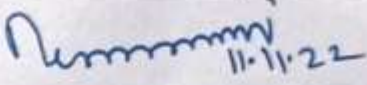
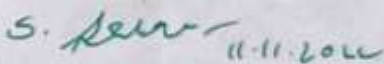
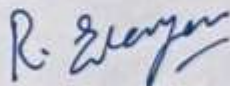

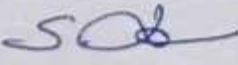
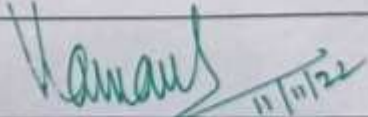
The following Agenda were discussed:

- Evaluation and suggestion for automation of academic and administrative activities for distance education programmes.
- Interact with and obtain feedback from all stakeholders namely learners, teachers, staff, parents, society, government etc for quality improvement.
- Suggestion to the authorities of the HEI, measures for qualitative improvement.
- Ensure that Programmes Project Report (PPR) for each programme is according to the norms and guidelines prescribed by the commission and ensure the proper implementation of PPR.
- Programme development with the Vision and Mission of the Institution.
- Maintain annual plans and annual reports of HEI, review them periodically and generate actionable reports.
- Need based curriculum design and include specific component of specialization.
- Facilitate system based research on ways of creating learner centric environment and to bring about qualitative change in the entire system.
- Maintaining quality of learning resources and to provide e-resources.
- The co-ordinate between HEI and the commission for various quality related initiatives or guidelines.
